



#### Economic Substance Regulations (ESR) Advisory

The Economic Substance Requirement, or ESR, regulation requires Mainland and Free Zone companies in the UAE (unless so exempted) conducting 'Relevant Activity' to submit an ESR Notification and ESR Report on the Ministry of Finance portal before the applicable deadlines.

The ESR requires companies to correctly assess their business activities beyond the activities listed in the business license to determine whether they are conducting any 'Relevant Activity' and subsequently demonstrate 'economic substance' in the UAE – i.e for carrying out that Relevant Activity in the UAE. The testing parameters for ESR compliance are:

- Adequate operating expenditure
- ✓ Adequate physical infrastructure or assets
- Directed and managed in the UAE

Beneficiary Owner Procedures requires all business entities (unless exempt by the regulation) to prepare, maintain, and submit a Beneficial Owner Register with its respective licensing authorities.

The UBO details have become critical after the implementation of the

Economic Substance Regulation in the UAE, as the ESR Report requires details of the Ultimate Parent Company and Ultimate Beneficial Owner and as a primary requirement of Anti-Money Laundering Regulation in the UAE, Cabinet Decision No. 58 of 2020.

#### Anti-Money Laundering (AML) and Counter Financing of Terrorism (CFT) Advisory

In December 2020, the UAE Cabinet adopted the formation of the Executive Office of the Anti-Money Laundering and Countering the Financing of Terrorism with an aim to follow the international requirements in this sector. All the requirements of the Financial Action Task Force (FATF) recommendations of 2012 and its methodology of 2013 are included in the AML Law.




